The undersigned agrees for valuable consideration, the receipt and sufficiency of which is acknowledged, that (s)he, and any relative(s), friend(s), and associate(s) of the undersigned, who enters the Emily Watson Eventing LLC/Savvy LLC/GlenAyre Equestrian Center (GEC) do so at their own risk and that Emily Watson, Ragan Family, nor their employees shall not be liable under any circumstances (whether due to the negligence of Emily Watson Eventing proprietor, its employees, or otherwise) for any injury to person(s) or property including death, consequential damages, economic loss, or other consequences or results of such injuries or any loss or damage suffered while on premises of the Emily Watson Eventing LLC, SAVVY LLC, GEC, PEOPLE’S PROPERTY.

The undersigned agrees to indemnify, hold harmless, and save EMILY WATSON, RAGAN FAMILY, THE PEOPLES FAMILY of and from all such liabilities and all claims and attorney's fees for any such injuries, loss, or damage, whether sustained by undersigned or any relative(s), friend(s), or associate(s) brought upon the EWE LLC., SAVVY LLC/GEC.

WARNING Under the Equine Activity Liability Act, each participant who engages in an equine activity expressly assumes the risks of engaging in and legal responsibility for injury, loss, or damage to person or property resulting from the risk of equine activities.

The terms of this Liability Agreement apply to all lesson horses or those leased or boarded at EWE LLC, SAVVY LLC, GLENAYRE EQUESTRIAN CENTRE whether on or off GEC property and any other activities performed on the GEC FARM.

This Agreement shall be attached to and by this reference is made a part of all Lease and/or Boarding Agreements between the parties hereto.

KYRS - 247.402 Warning of inherent risks; limitation of claims by participants; exceptions

- (1) The inherent risks of farm animal activities are deemed to be beyond the reasonable control of farm animal activity sponsors, farm animal professionals, or other persons. Therefore, farm animal activity sponsors, farm animal professionals, or other persons are deemed to have the duty to reasonably warn participants in farm animal activities of the inherent risks of the farm animal activities but not the duty to reduce or eliminate the inherent risks of farm animal activities. Except as provided in subsections (2) and (3) of this section, no participant or representative of a participant who has been reasonably warned of the inherent risks of farm animal activities shall make any claim against, maintain an action against, or recover from a farm animal activity sponsor, a farm animal professional, or any other person for injury, loss, damage, or death of the participant resulting from any of the inherent risks of farm animal activities.

Please continue and initial lesson policy.

- To cancel a lesson the instructor must be contact ***24 hours in advance*** of lesson and a make-up day can be scheduled. In case of emergency, please contact instructor as soon as possible.
- If a rider is late to a lesson, the lesson will still end at the scheduled ending time of the original lesson and full amount will be charged.
- No shows and no notice for lesson cancellations will be charge in full and a make-up day will not be allotted.
- Acceptable forms of payment are cash, invoiced through Quickbooks with the ability to pay via Bank transfer or credit card. All invoices are susceptible to late fees after 10 days of nonpayment.
- Upon completion of the introductory lessons, it is **HIGHLY** recommended for students to have their own helmet. A MIPS helmet is most highly recommended.
- Riding pants and proper riding boots are also required after the introductory phase. Paddock boots allow a flexibility of ankle that other boots do not.
- Camp is limited to 10 riders and staffing must be maintained throughout the week, there is no refund for camp once the session has begun.
